BUILDING PERMIT

(1) All work intending to construct, enlarge, alterpair, move, demolish, or change the occupancy of a building or structure, or to erecitistall, enlarge, alter, repair, move, convert or replace any impact-resistant coverings, electrical, gas, mechanical compling system, the installation of which is regulated by this code, or to cause any such work to be dismed, first make application to the building official and obtain the required permit.

(2) Construction or work for which a permit is remed shall be subject to inspection by the building official and such construction work shall remain accessible and exposed for inspection purposes until approved. Approval as a result of inspection shall not be construed an approval of a violation of the provisions of the code or of other ordinano esthe jurisdiction. Inspections presuming to give authority to violate or 9odNoo (3) at long broind the provisions to inspections

and shall either release that portion the construction of any violation which must be corrected in order comply with the codes.

- (4) It shall be the duty of the permit holder totifyothe building official when work is ready for inspection. It shall be the duty of the permit holder provide access to and means for inspections of such work that are required by the codes.
- (5) No building or structure shall be used **occupied**, and no change in existing occupancy classification of a building or structure or portionenter of shall be made, until the building official has issued a certificate of occupancy hall not be construed as an approval of violation of the provisions of this one or of other ordinates of the jurisdiction.

"State-leased" means that the state, any state agency or department, or the Trustees of the Internal Improvement Trust Fund is the lessee which is leasing the building or space from a lessor.
